The MPOA maintains 34 boat slips for use by members. In order to be placed on the boat slip waiting list you must be a member in good standing and submit this application form. Once on the list, your position will be maintained until a slip becomes available provided this form along with your membership application and fee is submitted by **March 1st** each year and you participate in dock/park projects annually. **If you fail to submit this annual renewal form by the March 1st deadline or if your membership lapses, or if you fail to participate in park/dock projects, you will lose your position and your name will be removed from the list.** The waiting list is posted on the board at the park and is updated periodically, but **it is your responsibility to keep track of your position on this list.** Boater meetings are held during the year and you are strongly urged to attend.

PLEASE NOTE: All are advised that the water depths, slip widths and pole spacings vary, and an available slip may not be suitable for your boat. Also, slip renters from the previous year are given first priority in slip assignments and are given an opportunity to retain their present slip or to request a slip that might be more suitable to their needs on a space available basis. In addition, slip No.1 is subject annually to a pre-emptive agreement which could reduce the number of available slips in any year to 33. If that were to occur, the newest slip renter would lose his slip until another became available, and he would be first in line for that slip.

When you are notified that a slip is available, and if you decline the offer, your name will be placed at the bottom of the waiting list. If you accept the slip, you will be expected to promptly occupy it after furnishing the required Boat Slip Application including all fees, a copy of the boat registration listing you as the owner and proof of a liability insurance policy in your name covering the boat and naming the MPOA as an additional insured. If you are unable to utilize the slip immediately, the MPOA will attempt to reassign it temporarily, until the end of the season if necessary and, if possible, will reimburse you for its use from the temporary rental. Your refund however, is contingent upon fees generated by the reassignment of the slip.

Your reservation may be extended the following year upon submittal of all information and the annual fees by **March 1st**, but in fairness to others on the waiting list, your boat must be in the slip by **May 1st**, or the reservation will be considered forfeited and your name will be placed at the bottom of the list. In that case the MPOA will once again attempt to reassign the slip and if possible, reimburse your fee from the new rental.

I _____, the undersigned, understand that my position on the boat slip waiting list is not transferable, and agree to all of the above conditions for placement of my name on the list. **I agree to abide by all of the conditions and rules of membership, to participate in park/dock clean-ups and maintenance projects and I understand that my position on the list is dependent upon my compliance.** I further understand that in case of scheduling or other conflicts with any of the above issues, I must notify the dock chairman of the problem so that a solution may be found.

If offered a boat slip, I will also abide by all of the additional rules and conditions associated with boat slip/ramp/rack usage.
