BOAT REGISTRATION & PROOF OF INSURANCE IS REQUIRED WITH APPLICATION ALONG WITH PAYMENT OF ALL FEES OR APPLICATION WILL NOT BE ACCEPTED and PRIORITY NOT ASSURED.

Boating and Membership applications are to be submitted with all documents and payments on or before **March 1st each year**. Priority of members who occupied a slip or rack the previous year will be considered forfeited if the applications are received after this date, and members on the waiting list will then become eligible for the slips or racks. All slips and racks will be assigned by **March 15th**. Boat privileges are granted to members in good standing who **assist with the park / dock clean-ups and maintenance projects and participate in the dock/park security program during their assigned weeks**; lack of compliance with these conditions will result in loss of boat privileges. Due to limited space, only one slip per member family.

NOTE: If you are assigned a slip and cannot occupy within a reasonable time, you **must** notify the dock chairman so that the next boater in line can be offered temporary use of the slip until you are able to occupy it. You must occupy the slip by May 1st of the following year or you will forfeit the slip and you will be placed at the bottom of the boat slip waiting list. Any fee reimbursement is contingent on fee generated by slip reassignment. *For Eligibility and Dock Policy questions or with problems or issues with any of the above conditions YOU must call the dock chairman.*

RELEASE OF LIABILITY AND RESPONSIBILITY – STATEMENT OF OWNERSHIP AND OBLIGATION

I _____, the undersigned, owner of the boat described above do hereby release the MPOA and its trustees from all responsibility, liability, and any claims or judgments for any damages, loss or injury, to person(s) or property incurred by me, my family or guests due to fire, theft, storms, vandalism, negligence, malicious mischief, accident, or actions of other persons while utilizing or keeping my boat at the docks or other areas owned and maintained by the MPOA, whether on land or water. I assume responsibility for actions of myself, my family and guests while utilizing these areas including their security and safety, as well as for damage or loss caused by my boat. I understand that these privileges are not transferable and state my boat is registered and insured in my name, as owner and as eligible member of MPOA. *I have read and will abide with the terms of this application and the Boat/ Park Rules & Regulations, and acknowledge use of the dock, ramp, rack and parking facilities are for MPOA MEMBERS ONLY*; keys to the gates, ramp and docks are for my personal use ONLY and are NOT to be duplicated or loaned to anyone; such action will result in loss of all privileges; guests must be accompanied by a member; ALL boats and lines are to be removed from MPOA property by Nov. 1st, unless otherwise notified by the dock committee. For special arrangements call dock chairman. I agree that the MPOA facilities are not to be used for business purposes. **I further agree to attend Boater meetings, participate in the Park/Dock Security program assignments, scheduled clean-ups and other Maintenance projects for the Park/Dock areas; failure to do so can result in loss of dock, ramp and rack privileges, including the 1 free launch and retrieve*.**
