ALL members using boating facilities, including free launch and retrieve, are required to participate in park/dock clean-up and maintenance projects annually, and all completed applications must be submitted prior to launch.

EARLY BIRD DUES: \$75.00 per household. Checks must be received on or before March 1st in order to be eligible. Regular dues are \$80.00 if received after March 1st. If after October 1st, FIRST-TIME NEW MEMBER dues for the balance of the first year are \$40.00.
